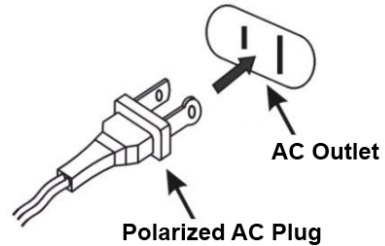

This product contains a low power laser device.

ON PROTECTION AGAINST LASER ENERGY EXPOSURE

- As the laser beam used in this compact disc player is harmful to the eyes, do not attempt to disassemble the casing.
- Stop operation immediately if any liquid or solid object should fall into the cabinet.

- Do not touch the lens or poke at it. If you do, you may damage the lens and the player may not operate properly.
- Do not put anything in the safety slot. If you do, the laser diode will be “ON” when the CD door is still open.
- If the unit is not to be used for a long period of time, make sure that all power sources are disconnected from the unit. Remove all batteries from the battery compartment, and unplug the AC cord from the wall outlet. Make it a practice to remove the AC cord by grasping the main body and not by pulling the cord.
- This unit employs a laser. The use of controls or adjustment or performance of procedures other than those specified here may result in exposure to hazardous radiation.

ON PLACEMENT

- Do not use the unit in places which are extremely hot, cold, dusty or humid.
- Place the unit on a flat and even surface.
- Do not restrict the air-flow of the unit by placing it in a place with poor ventilation, by covering it with a cloth or by placing it on a carpet.

ON CONDENSATION

- When left in a heated room where it is warm and damp, water droplets or condensation may form inside the unit.

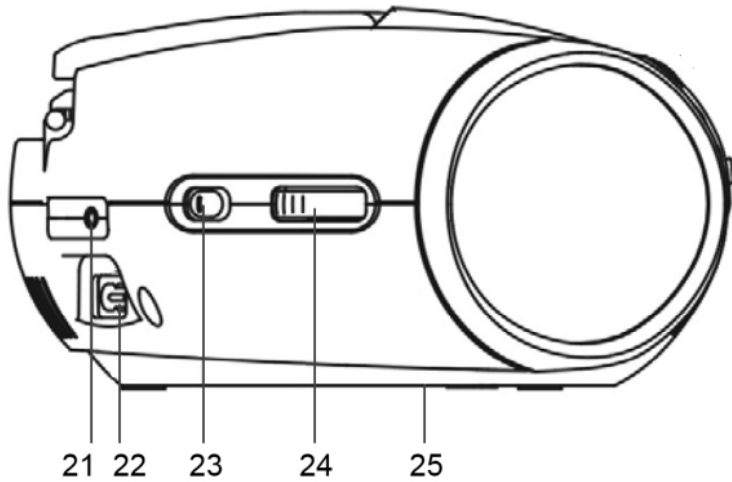
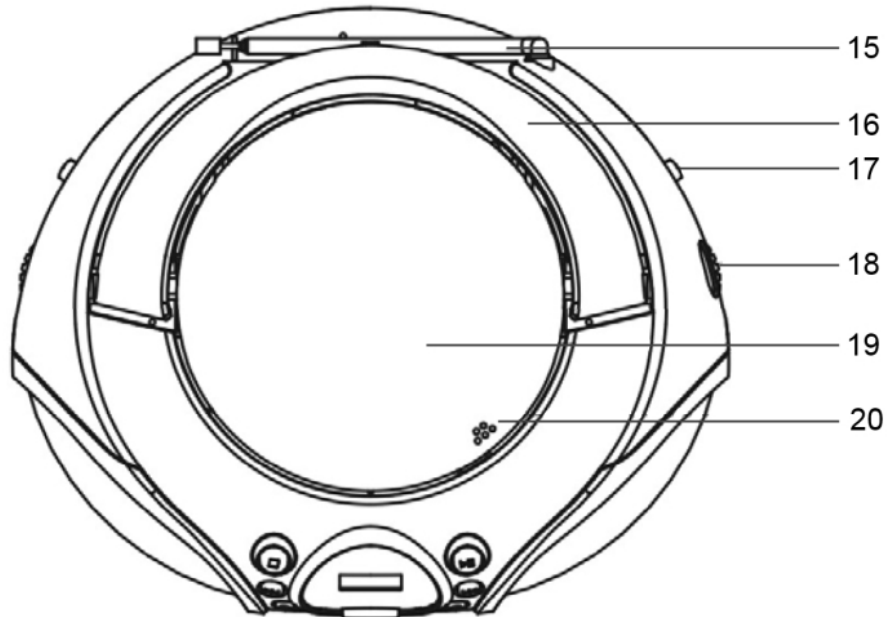
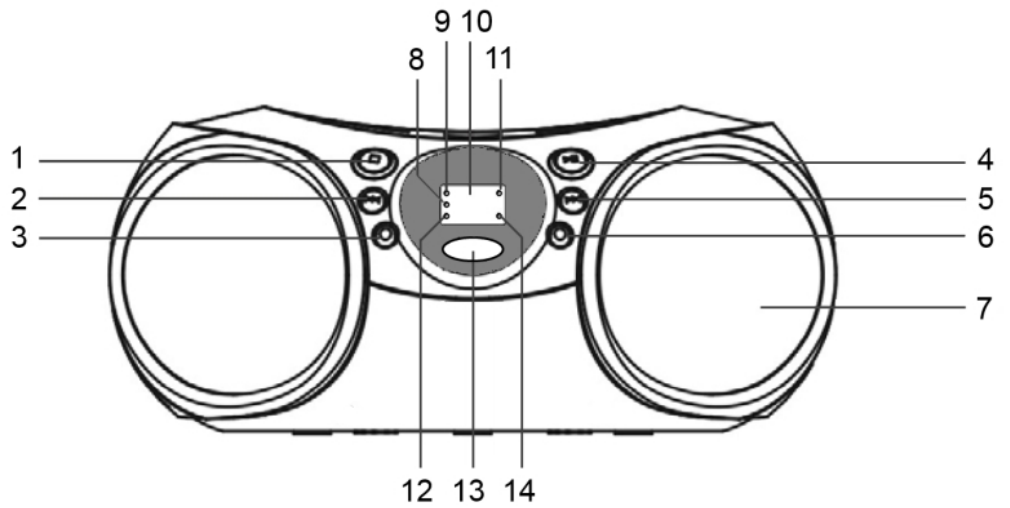

PROTECT YOUR FURNITURE!!

This system is equipped with non-skid rubber 'feet' to prevent the product from moving when you operate the controls. These 'feet' are made from non-migrating rubber material specially formulated to avoid leaving any marks or stains on your furniture. However certain types of oil based furniture polishes, wood preservatives, or cleaning sprays may cause the rubber 'feet' to soften, and leave marks or a rubber residue on the furniture.

To prevent any damage to your furniture we strongly recommend that you purchase small self-adhesive felt pads, available at hardware stores and home improvement centers everywhere, and apply these pads to the bottom of the rubber 'feet' before you place the product on fine wooden furniture.

POWER SOURCES

This unit operates on AC 120V~ 60Hz or 6 pieces of DC1.5V “C” (UM-2) batteries. Do not attempt to operate the radio on any other power source. You could cause damage to the unit and void your warranty.

Please be sure the power outlet you plug this unit into is working and receives constant power.

A. BATTERY OPERATION

1. Remove the BATTERY COMPARTMENT COVER.
2. Following the polarity diagram as shown inside the battery compartment insert 6 x ‘C’ (UM-2) batteries (not included) then replace the BATTERY COMPARTMENT COVER.

IMPORTANT: Be sure that the batteries are installed correctly. Wrong polarity may damage the unit.

3. Use only the size and type of batteries specified.
4. For better performance and longer operating time, we recommend alkaline-type batteries.
5. Do not mix old and new batteries.
6. Do not mix alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium) batteries.
7. If the unit is not to be used for an extended period of time, remove the batteries. Old or leaking batteries can cause damage to the unit and may void the warranty.
8. Do not try to recharge batteries not intended to be recharged; they can overheat and rupture. (Follow battery manufacturer’s directions).
9. Do not dispose of batteries in fire, batteries may leak or explode.

BATTERY REPLACEMENT

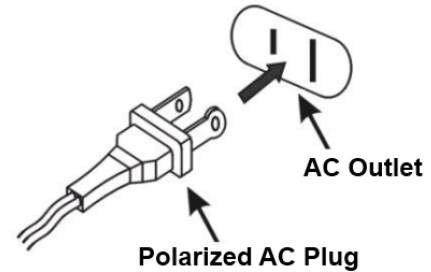
When the output sound of this unit becomes distorted or the CD player operation appears unstable, the batteries are weak. You need to replace all the exhausted batteries at the same time as soon as possible to avoid battery leakage.

B. AC OPERATION

When the plug of the provided AC POWER CORD is plugged into to a wall outlet with AC 120V~ 60Hz power supply, the unit will disconnect the batteries automatically, and operate from AC power instead.

IMPORTANT:

This unit has a polarized AC plug with one wide blade and one narrow blade. This plug will only fit into a matching polarized AC outlet. This is a safety feature to reduce the possibility of electric shock. If this plug will not fit in your AC outlet, you probably have an outdated non-polarized outlet. You should have your outdated outlet changed by a qualified, licensed electrician. Do not file the wide blade on the plug, or use an adapter to make the plug fit onto your outlet. This defeats the safety feature and could expose you to electric shock.



RADIO OPERATION

1. Slide the FUNCTION SELECTOR to "RADIO". The POWER INDICATOR will light.
2. Rotate the TUNING CONTROL to your desired radio station according to the DIAL SCALE.
3. Rotate the VOLUME CONTROL to adjust to the desired output level.
4. To turn off the radio, slide the FUNCTION SWITCH to "OFF".

TIPS FOR BEST RECEPTION

AM – The AM antenna is located inside the cabinet of the unit. If AM reception is weak, change the position of unit until the internal antenna picks up the strongest signal.

FM – If a stereo broadcast program is being received, the FM STEREO INDICATOR will light. During FM reception, always keep the TELESCOPIC ANTENNA fully extended for best performance. However, if FM reception is weak, try repositioning the unit near an open window until you get the best reception.

CD OPERATION

THIS UNIT NOT ONLY PLAYS COMMERCIAL COMPACT DISCS BUT ALSO SELF-COMPILED CD-RW DISCS.

- Because of non-standardized format definition/production of CD-R/RW, playback quality & performance is not guaranteed.
- Manufacturer is not responsible for the playability of CD-R/RW due to recording conditions such as PC performance, writing software, media properties etc.
- Do not attach a label or seal to either side of the CD-R/RW disc. It may cause a malfunction.

PLAY MODE

1. Slide the FUNCTION SELECTOR to the "CD/AUX" position. The POWER INDICATOR will light.
2. Open the CD COMPARTMENT COVER, the LED DISPLAY will show "00". Load a CD with the label side facing upward and then close it.
3. A few seconds later the total number of tracks on the CD will appear on the LED display.
4. Press the PLAY/PAUSE BUTTON to start playing the CD from the first track. The PLAY/PAUSE INDICATOR will light steadily.
5. Adjust the volume control to the desired volume level.
6. While playing, press the PLAY/PAUSE BUTTON once to pause, the PLAY/PAUSE INDICATOR will flash. Press PLAY/PAUSE BUTTON again to resume playing.

7. Press STOP BUTTON to stop playing.
8. To turn off the CD player, slide the FUNCTION SELECTOR to "OFF". The LED DISPLAY and POWER INDICATOR will go off.

Note: Never open the CD DOOR when a CD is playing to avoid possible exposure to laser radiation.

REPEAT MODE

Repeat 1

When the REPEAT BUTTON is pressed once, the REPEAT INDICATOR will light and blink continuously. The current track will be repeated until it is interrupted.

Repeat All

When the REPEAT BUTTON is pressed twice, the REPEAT INDICATOR will light steadily. The whole disc will be played continuously.

To Cancel the Repeat Function: Press the REPEAT BUTTON until the repeat indicator goes off.

SKIP AND SEARCH MODE

1. During Play or Pause mode, tap the NEXT or BACK BUTTON to go to the next track or go back to the beginning of the current track.
2. During Play mode or Pause mode, press and hold the NEXT/▶▶ or BACK/◀◀ BUTTON to search within the current track with audible high speed playback.

PROGRAM PLAY MODE

This function allows music tracks to be played in a programmed sequence.

Note: Program can only be set in STOP mode.

1. Press the PROGRAM BUTTON once. Both Program Number "01" and the PROGRAM (PROG) INDICATOR will flash.
2. Press the NEXT or BACK BUTTON to select the track to be programmed.
3. Press the PROGRAM BUTTON again to store the selection. The Program Number will advance to "02" and flash to prompt for the next input.
4. You may repeat steps #2 to #3 to program up to 20 tracks. As soon as you have entered the 20th track, the LED DISPLAY will automatically show the programmed tracks one by one in their correct sequence starting from the first. At the end of program review, Program Number "01" and the PROGRAM INDICATOR will both flash.
5. Press the PLAY BUTTON to complete and start program play. Otherwise, press the STOP BUTTON to complete and exit program mode.
6. To review/edit the programmed tracks during play, press the STOP BUTTON and then the PROGRAM BUTTON, the LED DISPLAY will show Program Number "01" and the PROGRAM INDICATOR will both flash. If you do not want to change any track in the program, press PLAY BUTTON or wait about 30 seconds to exit edit mode automatically.
7. To edit a programmed track, first press the PROGRAM BUTTON until you reach the program number whose track you want to change then press the NEXT or BACK BUTTON to select a new track and press PROGRAM BUTTON again to confirm.
8. To cancel program play, press the STOP BUTTON twice while reviewing programmed tracks or open the CD DOOR in STOP mode.
9. To turn off the CD player, slide the FUNCTION SELECTOR to "OFF". The LED DISPLAY and POWER INDICATOR will go off.

AUX IN OPERATION

This CD boombox provides an auxiliary input jack for connecting external audio devices like MP3 players and digital audio devices, and to listen to them through the speakers of this unit. Once the AUX IN jack is plugged in, this unit will switch from CD mode to the AUX mode automatically.

1. Use an audio cable (not included) with one 3.5 mm stereo plug on each end of the cable.
2. Plug one end of the cable into the AUX IN JACK and the other end into the Line-out Jack or Headphone Jack of your external audio device.
3. Turn on both the unit and your external audio device.
4. Set FUNCTION SELECTOR of CD boombox to "CD/AUX".
5. The volume level can now be controlled through the CD boombox. Operate all other functions on the auxiliary device as usual.

Note:

- If you connect this unit to the Line-Out Jack of your external device, you only need to adjust the volume control of the unit. If you connect to the Headphone Jack of your external device, you may need to adjust both the volume controls of your external device and the unit to obtain the desirable volume setting.
- Remember to turn off the unit when you have finished listening. Don't forget to switch off the power of your external audio device as well.
- Remember to disconnect the connection cable from the unit after use in order to be able to listen to CD music again.

CARE AND MAINTENANCE

1. Children should be supervised when using this appliance.
2. Clean your unit with a damp (never wet) cloth. Solvent or detergent should never be used.
3. Avoid leaving your unit in direct sunlight or in hot, humid or dusty places.
4. Keep your unit away from heating appliances and sources of electrical noise such as fluorescent lamps or motors.
5. If drop-outs or interruptions occur in the music during CD play, or if the CD fails to play at all, its bottom surface may require cleaning. Before playing, wipe the disc from the center outwards with a good soft cleaning cloth.
